LETS START FROM THE BASIC...

I am going to quickly show you how to **open, and verify a paypal account using a debit card and USA BANK account.**

Please keep away any distractions and read this info carefully because if you miss this part then you can NEVER UNDERSTAND the rest.

***Special Note; You will have to read all the pages in this report and then attach them together as they soothe you***

**We will first learn how to set up your own Paypal account, add a credit/debit card and finally verify the information!**

**STEP 1:** The first step is for you to open a paypal account. To open a paypal account you will need to go to the paypal websites, to do that go to [www.paypal.com](http://www.paypal.com)

Once the website loads, Look for the **sign up** button located at the very top of the website and click it.

**STEP 2:** Select your **REAL COUNTRY**. Choose your language and the type of account you want to open. I will advise you choose a **Business or Premier account**. After you have completed the information then move on to the next page.

**STEP 3:** In this next page you will be asked to fill up your other informations in the "Personal Data Fill up".

After you have completed the information you will be finally forwarded to another page where you will be asked to use either a debit/credit card or a USA bank account to complete your registration. Since you don't have that information just click cancel for now.

\*I will address the issue of how to open a USA bank account and getting a Debit/Credit card in later chapters.

**STEP 4:** When you have done the above steps correctly, then quickly go back to the email address you used while registering to check your mail box. You will immediately have receive an email from paypal, click it and below the email page you will see something that read this..

To complete your paypal account you must  
click the mail below and enter your password on  
the following page to confirm your email address  
[click here to activate your account](#)

**STEP 5:** Click the link and you will be finally directed to another page. Once you confirmed your email: you are done. You have successfully opened a paypal account.

## ***YOU ARE NOW PAYPAL ACTIVATED!***

You can already login at this point using your password and email. You will remain unverified until you add a credit card and a bank account. **Now lets get you paypal verified .. ;-)**

**But before i do i am sure that one question you might be asking right now is that how are you going to register like i stated above when you paypal doesn;t even accept Nigerians in there country list. Well you just keep reading and by the time you are done everything will be clearer to you**

Until you verify your paypal account:

1. You are limited on the amount you can send out.
2. You are not allowed to withdraw
3. Buyers will be hesitant to buy products from you, as VERIFIED means you are a genuine person. UNVERIFIED: you get the drift right?

There are two steps to getting verified in paypal. The first step is for you to verify using debit or credit card and the second part is for you to use a USA bank Account.

Not to worry i have outlined below how to get the two..

Getting Verified in your paypal account;

At this point since you have already registered you can login into your paypal account. Right there you will notice a boldly written word stating that your status is that : Unverified

### **STEP 1:**

The first step to verify your paypal account is to use a Credit Card or Debit card. Meanwhile this credit card must have the same billing address and name with the one you used when you were opening your account.

If you don't have a credit card you can order for one. And with just N5,000 which is equivalent to a \$25 card. Your paypal account will be verified. Contact me through my email to order for your own card.

### **STEP 2:**

This part i believe is what will really interest you. The second step to **Verifying** your paypal account is to Use a USA bank account.

Apart from even using a USA bank to verify your paypal account, the easiest way to withdraw money from your paypal account is for you to wire it directly into USA bank account which will later be withdrawn in cash using the USA ATM card.

Like i promised i am going to show you **HOW TO OPEN A USA BANK ACCOUNT FOR FREE.**

The first step is to go to the USA BANK website. You can find it at [www.etradebank.com](http://www.etradebank.com).

Well, let me start by giving some info about E\*trade. E\*trade is actually a brokerage company located in US managed by Bank of New York.

**First, let's address my concerns on why I least recommend this:**

E\*Trade is to put in a very nice way, SLOW in processing new accounts! They are very slow, trust my word, and now, due to their relocation to HongKong, are even worse ! Expect 1-2 even 3 months to go by before you will be able to use this method to make yourself Paypal verified.

**But hey, here is some good stuff about E\*Trade**

You will get a US based brokerage account and a VISA PLATINUM DEBIT CARD!

This is how the methods go. Follow carefully; I have provided step by-step instructions.

## Get your e\*trade registration form.

To do that go to [www.etradebank.com](http://www.etradebank.com) and click on **OPEN AN ACCOUNT**. When the page opens look for “forms and applications” link and then do the same thing by clicking on it. In this page that will be downloaded for you. Or go directly to

Look for “**E\*TRADE Complete™ Investment Account Application (Brokerage Investing Account)** . Download the PDF

Fill Out the Form

I will teach step by step on how to fill up the form. You should have 2 forms:

### Brokerage Account Kit and the W-8BEN

This is the info on how to fill up Brokerage Account Kit.

1. Choose Your Account Type: Tick Individual Account
- 2.

Enter Your Account Holder Information

.Fill up only the “Primary Account Holder Information

.Fill in VALID and LEGIT details

.Tick “NO” for the three question after state and zip

.In the passport number section: insert you government issued Card Number/ID,National ID,International passport.

.In the Passport country of issuance and Country of legal residence, ink in your REAL country

3. Create Your Investment Profile

Tick “Capital Preservation” and fill in the rest, as you like

4. Select Your Account Features

.In Taxable Income, tick on the second box

.Leave the Tax Exempt income empty. No need to fill anything

.Tick the two boxes in the cash management feature

5. Fund Your Account

Tick “I plan to wire funds from another financial institution”

## 6. Sign and Date Your Application

- .Tick on "I'm not a US Person (if you are not from US)
- .Put your signature and date
- .Write down the name you want on your Platinum Card in the "Printed name" section

First form is done. Let's move on to the second form W-8BEN.

This is the info on how to fill up W-8BEN

### 1. Identification Of Beneficial Owner

- .Jot down your full name
- .Tick individual on the "type of beneficial owner"
- .Jot down your personal address

### 2. Claims Of Tax Treaty Benefit

Tick "a" and write down the name of your country

### 3. Notional Principle Contracts

Tick Box 11

### 4. Certification

Sign on the dotted line and fill in the date

In the section: In Capacity in Which acting, write individual.

Done. You have filled out the form

**Step 3:** Send in the form

Now you need to send in the form to e\*trade. Important: You need to send them

1. The brokerage form
2. W-8ben form
3. Your Government ID photocopy

Make sure you attach all three forms I mentioned above for your application to be successfully processed.

This is the address that you need to send to Hong Kong.

**Step 4: Kick Back and Wait**

Now, it will take them 1 to 2 months (sometimes even 3 months) to get back to you, and this depends from where you sent the application and how you mailed them i.e local post or express post. Understand, a lot of time, will be wasted for your mail to be delivered if you send in by local post. **Send your application by express mail** You should always keep in check with E\*trade on whether your application has been received or not. Contact them once in a while to enquirer on the status of your application. I have attached the contact numbers, the best time to call them and their customer support emails below:

Do keep in check with them once in a while, so that you will know the status of your application. This is better than waiting in the dark for months.

Once your mail arrives from E\*trade, go to:

**Step 5: Set Up Your E\*Trade Account**

You will receive 2 mails, separately. The 2 mails contain:

1. Account Login Information
1. Account Login Password

Follow the instruction in the letters to login to you E\*trade account. **Note:** It will take between 1-2 weeks for the second letter to arrive after the first one.

Quick Note:

Once you are logged in, you will notice that, your account is limited in access and functions. This is their security function. To be able to view your online account balance, account statements, and use full online features, you need to verify your account. Photocopy your government identity card and fax it to them. It must match the one you sent previously. Ask for the fax number by calling them using the telephone number I have provided.

**Important:** Before faxing, make sure that you write your 8 digit e\*trade account number at the top corner of your photocopy.

**Step 6: Get Your FREE Visa Platinum Debit Card**

To get the FREE debit card, you must have at least USD\$25.00 in your E\*trade account.

Now you can contact E\*trade and ask how you can transfer money into your account. They accept Wire transfer (that is what I did), but I suggest you email them to ask for options Once you have the necessary funds (you can only apply for the card once you have the funds inside it) login into e\*trade, and apply for your VISA Platinum debit card.

*I hope you are following the steps. If not take a little break and then get back later to it.*

By now once you have gotten your account details from e\*trade. Then go back to [www.paypal.com](http://www.paypal.com) and get your Account Verified.

***YOU HAVE BEEN ABLE TO SAFELY AND VERIFY YOUR

Once again while the above method showed you how to open and then verify your paypal account. Since paypal don't have Nigeria on there country list,what do we do then?

Well not to worry. I am going to show you right now **How to safely have a virtual office address in any country** of your choice...Check it out

**Introduction:** A virtual office is actually a service where you pay to share the cost of an office setup. You will share the office address and its facilities such as fax, mail-forwarding and so on as well. . Sometimes, the easiest way to overcome your problem in opening your account is simply to “jump country”.No joke.

If you are from one of Paypal’s non-accepted country, become a citizen of an “accepted” country near to your real country. Now how to shop around for a paypal “accepted country”? Simple! Look for an adopted country, which Paypal allows you to withdraw your paypal funds to both the “adopted” country’s bank and/or a US bank. I will tell you why later. It will save you a lot of time, and hassle

With a Virtual Address you will get your own foreign address meant just for you. Nobody else gets this address except you. You also gets a USA phone number which means you can receive calls...but its voice mail only.

There are several companies online that gives virtual address. You can do a Google search on that. Meanwhile the one i use is [www.graphcard.com](http://www.graphcard.com) and with just \$9 a month you will get a USA virtual address. With this address it means you have a company in the U.S.A also you can receive foreign checks from your virtual address.

So go over to [www.graphcard.com](http://www.graphcard.com) and get registered,it's free. After your registration,login into your account and look for the “virtual address” link. Follow the instructions,make your payment and instantly you get your personalize USA address.

When you have receive your Virtual address,then you need to go back to step one,follow the instructions and you will be able to Open,Verify your paypal account. Without any problems....Guaranteed!!!

If you have been following me from the beginning you will have seen that it is very easy to open a paypal account in Nigeria. All you need is—

- 1}Get a Virtual address
- 2}Open your paypal account
- 3}Verify your account using your USA bank account and Credit card

# But Paypal Geo-Tracks IP. What To Do?

Do you know that paypal keeps record of your IP log? Paypal is not as stupid as you think.

You can only fool them for so long. The thing is, Paypal can detect your ID if you are log in from their non-accepted country list, and block your access. Even worse, they might even close it down, if they suspect a fraud.

## **How do you go around solving this big headache?**

We know that Paypal geo-track your IP, and proxy sites are not reliable anymore to access Paypal.

How do you access your paypal account from your own country, **with Paypal's blessing?**

Get your IP address in Paypal's good books.

This is what a friend of mine did. He is from Pakistan, and he opened a Singapore virtual office and registered his account using his virtual office address. He emailed Paypal, and told them that he is "moving" to Pakistan for work purposes, and he will need to access his Paypal account from there.

He was emailed back and was asked to provide a unique IP that he will use to access his account from Pakistan. They only allow one particular IP address for one account. He sent it, and the last time I checked, he has been using his Paypal with no problem from Pakistan. ;-)

I suggest you going the real and legit way, and inform Paypal firsthand before they catch you accessing your account from their "non accepted country". This will save you a lot of time, and from "frozen funds"..

## Method No 4

Let's say you have a friend/relatives/acquaintance that you can trust to handle your finances. Let's assume as well that he/she is from a paypal-accepted country. You can basically use their account as yours if they provide you a sub account under their paypal account.

Here is the good thing; paypal actually will differentiate your money from his, so it will be easy to keep tabs.

**Now here is the risk for you:** The money will be under their account.

**Now here is the risk for them:** If you did something wrong, they will be held accountable. This can mean anything from getting paypalslap i.e limited access, or even worse, their account closed. Only use this method if you can trust your money (literally saying) with your acquaintance.

All you need to do is provide an email and ask your friend to open it up.

Note: If you use this method, your paypal login will be using a UserID not an email address. Consider only using this as a temporary solution.

**This is the end of the 4 methods to open a Paypal account. I believe that except you are lazy or you haven;t be following me your head should be bubbling by now with ideas on opening your own paypal account.**

## **Bonus: Click Your Way into Clickbank**

Now that we have (hopefully) solved your paypal problem, let's pull up our sleeves, and try to get you into Clickbank as well.

How?

This method works if you used the 4th method: Virtual Office.

By now you should know, this method opens you to the possibility and freedom the country has in terms of recognition with both Paypal and Clickbank.

Use the same method to open a clickbank account, and direct your earnings (checks) to your virtual office mail address. And then transfer your check to your home address which will be finally converted into cash when you get it deposited in your Domiciliary account.

# Before you go....

I have to admit that this book or should i say e-book might be a little bit imperfect. But trust me if you follow the steps i have outlined here carefully and then add a little of your own knowledge you will be able to safely open a paypal and clickbank account.
